TUITION PAYMENT SELECTION:

In consideration of the acceptance of enrollment by Country Village Montessori School (CVMS), I hereby agree to pay the balance of tuition in accordance with the tuition schedule set forth above under the following payment plan:

- One single annual payment, due June 1, 2017 or upon enrollment.
- Monthly payments in ten (10) installments, with the first payment due June 1, 2017 and each remaining payment due the first of the month beginning September 1, 2017 and ending May 1, 2018.

I understand that my obligation to pay the **FULL ANNUAL TUITION** is unconditional and no part of these charges, paid or outstanding, will be refunded or canceled in the event of absence, withdrawal or dismissal of the above student from the school **EXCEPT** in accordance with the Tuition Policy. The school reserves the right to request a parent to remove his/her child from any program due to disruptive behavior or if the child is found to be developmentally not ready.

FIRST TUITION PAYMENT:

I understand that my non-refundable first tuition payment is due by June 1, 2017 or upon enrollment and that if I do not make this payment CVMS is no longer obligated to reserve a place for my child and all fees are surrendered to CVMS.

ENROLLMENT DEPOSIT AND MATERIAL FEE:

To reserve the enrollment I have indicated above, I have enclosed a non-refundable deposit of \$100.00 and a non-refundable Materials Fee in the amount appropriate to the program selection that above.

LATE PAYMENTS AND RETURNED CHECKS:

I understand that a late fee of \$30 should be added to the tuition payment after the 10th of the month and that a fee of \$30 will be assessed in the event of a returned check.
